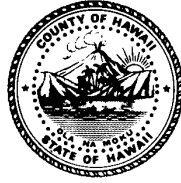

### **Integrated Solid Waste Management Plan Update PUBLIC HEARINGS**

Every ten years the County of Hawai'i Solid Waste Division is required to update its Integrated Solid Waste Management Plan (ISWMP or the Plan), per §HRS 342G.

The Public Comment period is open for sixty (60) days, from December 6, 2019 through February 4, 2020 and we encourage all those interested in submitting comments to do so during that time period.
