Should the successful bidder fail to remove the vehicle(s) from County property within the specified time, or fail to make payment as specified, the County reserves the right to resell the vehicle(s) or to award the bid to the next highest bidder. In such event, the defaulting bidder shall forfeit all claims to the proceeds and to the vehicle(s) and shall receive no reimbursement for any expenses whatsoever. The defaulting bidder shall also forfeit all amounts paid for the sale. Furthermore, the Director or Deputy Director reserves the right to suspend the defaulting bidder from bidding on any County auction for a period of one year or longer.

## 12. Waiver of Minor Deviations

The Director or Deputy Director of the Department of Environmental Management reserves the right to waive and/or accept any minor deviations from the Terms and Conditions, if in the Director's or Deputy Director's opinion such waiver will be in the best interest of the County, and that such waiver shall not in any way affect the standards of performance or operation.

#### 13. Interpretation

In case of any doubt as to the interpretation of these Terms and Conditions, the interpretation given and made by the Director, Deputy Director or the Director's authorized representative shall govern and control.

#### 14. Examination of Documents

It will be conclusively presumed that the bidder has read, examined, and agreed to each and every term, condition, provision, covenant or agreement in these Terms and Conditions.

#### 15. Indemnity

The successful bidder shall be responsible for all damages to persons or property that may occur in the removal and subsequent use or disposal of the described vehicle(s) as a result of successful bidder's conduct or negligence, or the conduct or negligence of its employees, agents or representatives. The successful bidder will observe, perform, and comply with all laws, statutes, ordinances, rules and regulations of the Federal Government, State of Hawai'i, County of Hawai'i, or any department or agency of the above. The successful bidder shall also indemnify, save and hold harmless, the County, its officers, agents, and employees, against all actions, suits, damages and claims by whomsoever brought or made by reason of the non-observance, non-performance or non-compliance with the said laws, statutes, ordinances, and rules and regulations.
